6. Access to Care Committee (update from Mickey)

- Have not heard from physicians for a few months.
- Ron said the 'lab services issue' is still in "information gathering mode."
- Hospice Society: With only 8 acute beds, there is no dedicated hospice space in the Hospital. There is a 'preferred' hospice room, but there is no guarantee that hospice needs can be accommodated in it. The Hospice Society would like to see referrals come earlier in the process (at the moment of a terminal diagnosis).

7. Seniors Helping Seniors Committee

- Volunteer needed to lead this initiative.

8. Transportation Committee

- Leslie Adams noted that transit is not on the radar of Town Council; and it is on the radar of Area A, but not a priority at this time.
- Susan received a response from Deanna Lacasse regarding the insurance implications, which would accompany ride sharing. Western Financial Group's response is below:

- Mickey is hearing of long waiting lists to get into assisted-living in Golden. Ron suggested that there are people on the Purcellview waiting list, that aren't ready to move.

11. AFCC Coordinator Sustainability (update from Ryan)

- Bill Barger of BCCRN has offered some support (\$1,500/yr) if Golden starts a Community Response Network.
- Ryan submitted a delegation request for December 15th and prepared a proposal for funding to be submitted to Council (attached). The proposal calls for 50:50 support from Town of Golden and Area A. AFCC member support was appreciated at Town Council at 1:15pm on Tuesday December 15th.
