

## **COLUMBIA SHUSWAP REGIONAL DISTRICT**

### **BYLAW NO. 5342**

**A bylaw to establish an economic development service  
within Electoral Area 'A' of the Columbia Shuswap Regional District**

WHEREAS a regional district may, by bylaw, establish and operate a service under the provisions of Part 24 of the Local Government Act;

AND WHEREAS the Board of the Columbia Shuswap Regional District wishes to establish a service for the purpose of providing economic development for Electoral Area 'A';

AND WHEREAS the Director for Electoral Area 'A' has consented, in writing, to the adoption of this bylaw and the service can be established without borrowing;

NOW THEREFORE the Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

1. The Regional District hereby establishes a local service for the provision of economic development for Electoral Area 'A', and which shall be known as the "Economic Development (Electoral Area 'A') Service Area."
2. The boundaries of the service area are the boundaries of Electoral Area 'A'.
3. The participating area in the named service established under Section 1 is Electoral Area 'A'.
4. The costs of providing the service established under Section 1 shall be recovered by requisition of money to be collected by a property value tax on the basis of the converted value of land and improvements.
5. The Regional District may enter into contractual arrangements for the delivery of this service.

6 This bylaw may be cited as "Economic Development (Electoral Area 'A') Service Bylaw No. 5342."


