BYLAW NO. 5342

A bylaw to establish an economic development service within Electoral Area 'A' of the Columbia Shuswap Regional District

WHEREAS a regional district may, by bylaw, establish and operate a service under the provisions of Part 24 of the Local Government Act;

AND WHEREAS the Board of the Columbia Shuswap Regional District wishes to establish a service for the purpose of providing economic development for Electoral Area 'A';

AND WHEREAS the Director for Electoral Area 'A' has consented, in writing, to the adoption of this bylaw and the service can be established without borrowing;

NOW THEREFORE the Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

- 1. The Regional District hereby establishes a local service for the provision of economic development for Electoral Area 'A', and which shall be known as the "Economic Development (Electoral Area 'A') Service Area."
- 2. The boundaries of the service area are the boundaries of Electoral Area 'A'.
- 3. The participating area in the named service established under Section 1 is Electoral Area 'A'.
- 4. The costs of providing the service established under Section 1 shall be recovered by requisition of money to be collected by a property value tax on the basis of the converted value of land and improvements.
- 5. The Regional District may enter into contractual arrangements for the delivery of this service.
